NO IMPORTS OR PURCHASED ITEMS WILL BE ALLOWED!** This is a juried show and only the highest quality crafts will be accepted. The jury committee reserves the right of approval of all merchandise. You may only sell items approved by the craft fair coordinator. This is a well-publicized and advertised show.

SHOW HOURS: Saturday, June 26 - 10 am to 6 pm

SET-UP TIME: Saturday, June 26 - 7 am to 9 am
Sunday, June 27 - 7 am to 9 am

BOOTH RENTAL: Fees: \$175.00 single, \$350.00 double (Single booths are approximately 10 x 10). **PLEASE INCLUDE \$10 NON-REFUNDABLE JURY FEE TO THE BOOTH FEE**

LOCATION: "*Strawberry Festival Country Craft Fair*" is being held in conjunction with the Annual Strawberry Festival. Booths will be located outdoors and will be positioned on both the east and west sides of Washington Avenue. Booths located on the east side of Washington Avenue must tear down on Saturday night and set-up again on Sunday morning. A few booths on the west side must also tear down on Saturday night. There will also be booths in the Community Center Gym. You may set up in the gym on Friday night, June 25th.
Historic Cedarburg is located 17 miles north of Milwaukee on I-43. Cedarburg exit (Hwy C) west 3 miles to Hwy 57 (Washington Ave.), north to downtown Cedarburg. From Hwy 41, exit Hwy 60, east to I-43, south to Cedarburg.

DEADLINE: Full payment is due at the time the application is sent in for consideration. If you are not accepted your fee will be returned to you by May 15th. Confirmation of acceptance into this show will be made by May 1ST. All artists must send photos of all work to be juried. Please send one picture of booth set-up. These pictures will either be returned at the show or mailed back to you. The artist renting the booth must be the one who makes the merchandise in the booth. Deadline is May 1st for applications. **PLEASE SEND A SELF-ADDRESSED STAMPED ENVELOPE WITH YOUR APPLICATION. POSTAGE ON THIS ENVELOPE SHOULD BE AT LEAST \$1.00**
